- 5. The vehicle should not be older than 2023 model, if quotated lowest rates are same more than one tenderer than latest model would be given preference
- 6. Providing fuel, lubricants, dusters and maintenance etc. for the vehicle will be the responsibility of the supplier/ owner.
- 7. The vehicle should be placed within 03 (three) days from the date of issue of final order.
- 8. The driver should be given prescribed liveries by the supplier.
